Unum Group is headquartered in Chattanooga, Tennessee. Through its three operating segments — [Unum US](#), [Unum UK](#) and [Colonial Life](#) — the company is a leading provider of employee benefits in both the United States and the United Kingdom.

The company follows the calendar year for reporting its financial results. Following the closing of each operating quarter, Unum Group provides data on its financial performance via formal filings with the Securities and Exchange Commission as well as a press release and an earnings conference call. The company provides information on its operations and strategy through regular participation in industry and investor conferences. On an annual basis, Unum Group hosts its own investor day conference and an annual meeting for its stockholders.

Shares of the company's common stock trade on the New York Stock Exchange under the ticker symbol "UNM." Unum Group is a member of the Fortune 500 and is a constituent member of the S&P 500 and the S&P Life and Health index along with other indices.

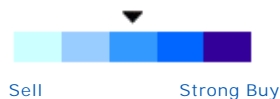
